# Minute of CPGIS BOD Monthly Meeting

Meeting Period: December 19, 2011 -January 6, 2012. The period is longer than usual due to the holidays.

Meeting Participants: The entire BOD

## **Meeting Discussion:**

1. Updates from the President' Office:

Diansheng Guo: For the past month, the President Office has been focusing on the following issues:

- (1) Student Paper Competition at GeoInformatics 2012. This year the submission deadline for conference papers is much earlier than in the past. So we extended the deadline to Jan. 15, 2012 and tried to spread the word through various email lists.
- (2) Budget Report. As the treasurer of the last term, I integrated the income/expenses at two offices (Michigan and China Station). The starting balance was \$19,547.19 (as of Jan. 1, 2011) and the ending balance is \$37,220.97 (as of Dec. 21, 2011). Two issues might be improved with our financial management and accounting:
  - We have balances at two offices (Michigan and China), which can be complicated in terms of synchronizing income/expenses.
  - We might also improve our budget approval, accounting, and reporting procedure. In addition to an annual report, maybe we can try to have quarterly report
- (3) AAG Get-Together. Chuanrong, Pinde, and I have discussed the date for our annual gathering at the AAG in New York.
- (4) Forming Committees.

- (5) Member Recruiting. We might need to take a more aggressive approach to reach out and find prospective members.
- 2. On Major Objectives, Problems, and Priority of the BOD: Bing Xu: Further strengthen the academic exchange between the US and China. The format can be in scholar exchange or visiting programs' set up in

both sides, or any others. Research funding support in China significantly increases and continues to increase with surprisingly stable and promising trend in recent few years. The exchange can be facilitated in various format.

From China side, to invite scholars oversees including professors, postdocs, or students to make short term or long term visit conducting research or lecturing, or China scholars including professors, postdocs, or students go oversees to visit short term or long term, is workable. Funding support in China can be obtained from various sources including universities, institutions, and agencies. The possible program can be initiated and implemented at irregular intervals due to unpredictable economy in nature.

Xun Shi: A set purpose of CPGIS is to facilitate academic exchange between US and China in the area of GIScience. We have several established programs, including Go Home, Young Scholar Summit, Advanced GIS Training in GMU and ESRI. Each has its own program committee under the President's Office. We can substantiate ideas and establish new program or programs? For example, sometimes I received inquiries from scholars in China who had got fellowships from the government or universities for them to study abroad for a period. They need to find institutions in the US (or other countries) to host them. We can provide this kind of service.

#### 3. On the 2012 Excellence in Education award:

Pinde Fu: I propose that we have the candidates nominated by May 1 2012 and voted by June 1. We can then issue the award at the Geoinformatics conference in June.

Xun Shi: I think the Education Award issue can be decided by its committee. Pinde can talk with Diansheng about this committee in the new term.

## 4. Updates about GeoInformatics 2012:

Xun Shi: We received about 300 submissions. Hui's idea is to accept about 200 for oral presentation. For the rest, we either accept for poster presentation or reject. A couple of graduate students in Chengdu are helping me sort out all the submissions and match them to reviewers (members of the Program Committee). The review will start soon after the New Year.

### 5. On new Honorary Members:

Xun Shi: The two nominations are strong, and I don't see why not.

Pinde Fu: I vote yes on both candidates.

Yuemin Ding: I agree that the two nominations for the honorary members are very strong. I am second to put that item up for vote in BOD meeting this month.

## 6. On the 20th Anniversary of CPGIS

Xun Shi: Yuemin is carrying on great workload and is in charge of both brochure compilation and souvenir design. Pinde has created the website for the webGIS of CPGIS - we need a good name for it, something like "Footprints of CPGIS" (please suggest). They all need help and support.

Shuming Bao (the Director of the Headquarters): We should try to find some sponsors for those printings and not spend CPGIS fund.

Yuemin Ding: I like the idea to create online video link instead of CD/DVD, like online photos. I think we can print a brochure, and one kind of T-Shirt as a souvenir, and a memento book. Hopefully we will find sponsors to support financially. We will still need some volunteers for providing the materials for the 20th Anniversary Brochure. What is the latest status of our application as a non-profit organization? I am looking forward to see it done, so I can send some donation from my company's foundation.

## **Vote on New Honorary Members:**

On January 2, 2012, Xun Shi, the coordinator of the meeting, called for vote from the BOD members on the two nominations of CPGIS Honorary Members.

By the deadline on January 5, 2012, Xun Shi received valid votes from Bing Xu, Daogin Tong, Desheng Liu, Pinde Fu, Qinghua Guo, Diansheng Guo, Shaowen Wang, Yuemin Ding, Xiaobai Yao, Shixiong Hu, and Xun Shi.

All votes are for the two nominations, and thus Drs. Jack Dangermond and Roger Tomlinson are named to be the Honorary Members of CPGIS.

Diansheng Guo, the President of CPGIS, will be in contact with the two honorees about this decision.

## CPGIS was approved to be exempt from Federal Income Tax (501(c)(3) status)

Dear CPGISers,

We are glad to inform you all that CPGIS has been approved by the United States Internal Revenue Service (IRS) to be exempted from federal income tax under the section of 501(c)(3) of the Internal Revenue Code. CPGIS is classified as a public charity and qualified to receive tax deductible bequests, devises, transfers or gifts from the public.

Below is a brief summary of milestones of the application:

- Aug. 3rd, 2010, a lawyer was hired.
- Sep. 16th. 2010, a contract was signed with the lawyer based on a budget approved by CPGIS BOD.
- Jun. 13th, 2011, CPGIS articles, submitted by the lawyer, were approved by the State of Michigan.
- Aug. 15th, 2011, based on materials provided by CPGIS, the lawyer submitted the application to IRS for non-profit organization classification.
- Feb. 20th, 2012, IRS required us to provide more materials. We printed every page of the CPGIS website, signed each page and mailed to IRS.
- Mar. 8th, 2012, all required materials were mailed to IRS by the lawyer.
- Mar. 21th, 2012, we received the notice from the lawyer that the application was approved by IRS.

The approved tax exempt status makes CPGIS eligible to receive charities and donations from the public. This will improve the financial situation of CPGIS and provide a better platform for CPGIS to make greater contribution to promoting academic exchange and education around the world.

# 2012 CPGIS "Go Home" Project Call for participation

Location: Huhehaote & Guangzhou, China

Date: June 9-14, 2012

## **Project Background**

The "Go Home" Project is one of a series of summer activities sponsored by The International Association for Chinese Professionals in Geographical Information Sciences (CPGIS), a non-profit organization that aims to promote professional development in GIS and related technology by fostering cooperation among its members. This project is specifically designed to encourage academic and professional exchanges between domestic and overseas Chinese GIS professionals through advanced GIS seminars and follow-up discussion held in selected universities and research institutes in China. With the purpose of introducing advanced spatial information technology to academics and professionals in different regions of China, the "Go Home" Project is a continuation of CPGIS' successful "Go West" Project launched in 2002 in response to the "Western China Development" strategy. The project was renamed "Go Home" in 2007, with a new goal of strengthening the communication of overseas CPGIS scholars with GIS professionals and students in all regions of China.

## **Project Details**

With the support of Inner Mongolia Normal University and South China Normal University, the CPGIS "Go Home" project will organize advanced GIS seminars in the summer of 2012 in **Huhehaote (Hohhot) and Guangzhou**.

With the fast development of economy in Inner Mongolia recent years, and Guangzhou being the center of the well-developed Pearl River Delta Metropolitan area, the land use and land cover are experiencing huge changes, local natural environment and ecosystems are facing tremendous challenges. The theme of this year's "Go Home" project will be on the *Application of Geospatial Technology in Natural Environment and Urban Development*. The project will select 4-5 established GIS scholars to deliver seminars in their area of specialty to the faculty members and students of the local hosting institutes. A tentative plan is as follows:

#### Time and Location:

June 9-12 Advanced seminars at Inner Mongolia Normal University (Huhehaote) June 12-14 Advanced seminars at South China Normal University (Guangzhou) June 14 Take train to Hong Kong and attend the Geoinformatics 2012 Conference

**Activities:** Each selected individual will present one research talk in one of the suggested areas. Follow-up discussions will also be arranged. A roundtable discussion with local professionals and governmental officials will be also organized.

**Expenses**: Lodging, meal, airfare from a domestic city in China to Huhehaote, and from Huhehaote to Guangzhou, Guangzhou to Hong Kong will be covered by the local hosting institute. During the event, local city tours and a tour to Inner Mongolia Grassland will be arranged. The cost will be covered by local hosts as well.

## Call for Proposals for CPGIS Young Scholar Workshops in China

Location: Guangzhou and Kaifeng, China

**Date**: June 17-23, 2012

CPGIS, in conjunction with Guangzhou University & Henan University, will organize the CPGIS young scholar workshops in China this summer. With Guangzhou being the center of the well-developed Pearl River Delta Metropolitan area, and Kaifeng being part of the emerging Zhengzhou-Kaifeng-Ruoyang Metropolitan area, the theme of this year is: *Advanced Geotechnology in Natural Resources Management and Urban Planning.* The project will select 4-5 young GIS scholars to deliver seminars in their area of specialty to the faculty members and students of the local hosting institutes. A tentative plan is as follows:

### Time and Location:

June 17-19 Advanced Workshops at Guangzhou University

June 20-23, Advanced Workshops at Henan University

Organizer: The international association for Chinese Professionals in Geographical

Information Sciences (CPGIS)

Local Hosts: Guangzhou University (Prof. Zhifeng Wu) and Henan University (Prof. Yaochen Qin)

**Format:** The participation will be composed of two parts: an open lecture and a research presentation. Each Young scholar from CPGIS needs to give an open lecture to the general public. The topic of lecture will focus on at least one geospatial technique or modeling methodology at his/her specialty. The lecture is estimated to last about one hour. Each Young scholar will also deliver a research presentation that best represents his/her research.

CPGIS is currently soliciting a one-page proposal from outstanding individuals who are interested in participating this event. The proposal should include a brief description of your proposed lecture content and research presentation. The final selection will be made based on the merit of proposal, the relevance of the proposal to the theme of the project, as well as the qualification of applicants.

**Cost:** Local hosts will provide domestic round trip tickets (a domestic city or Hong Kong to Guangzhou, Guangzhou to Kaifeng and Kaifeng to your domestic destination), local lodging and city tours. A tour to Shaolin Temple and Songshan Mountain will be arranged after the event. The cost will be covered by local host as well.
